Mr. Haines advised the Town has secured a POA Prosecutor to assist with prosecution matters in POA Court and during a consultation which the Prosecutor it was identified the current Agreement and Designation with AgapiK9 is not sufficient to permit them to issue POA Offence Notices under Dog Control By-Law and Dog Owners Liability Act. This has resulted in the dismissal of a recent charge. Staff will be reviewing the matter, with further information to come forward to Council.
